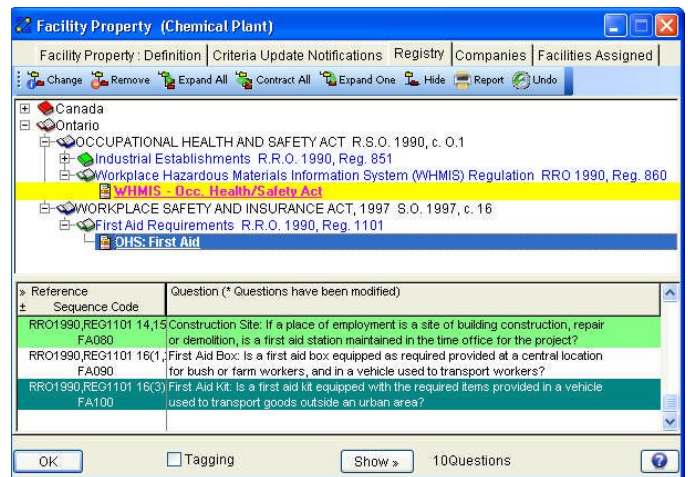
### Legal and Other Requirements Registries for Facilities Prepared in Minutes!

Simply drag an Act or Regulation from the Legislation Toolbar into a user-defined Facility Property—the legislation's legal requirements are automatically listed.

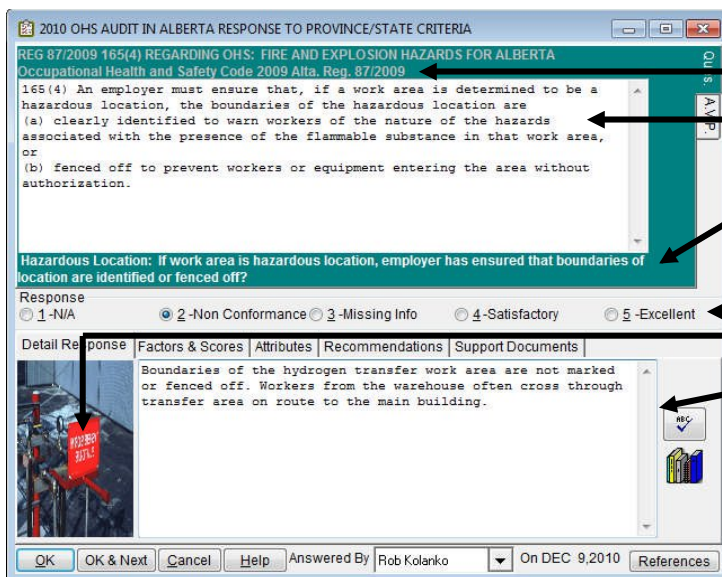

Actual Section of Legislation that the audit question is based on

Audit Question; clearly describes the industry requirement from the regulation

#### Finding Component

Customizable multiple-choice response

Easily attach a picture to support the finding

Enter text finding with spell checking

#### Findings Support

**Scores** Respond to risk factors and show user defined scores.

**Attributes** Enter properties for root cause analysis

**Recommendations** Enter with action plans

**Supporting Documents** Attach working papers and images

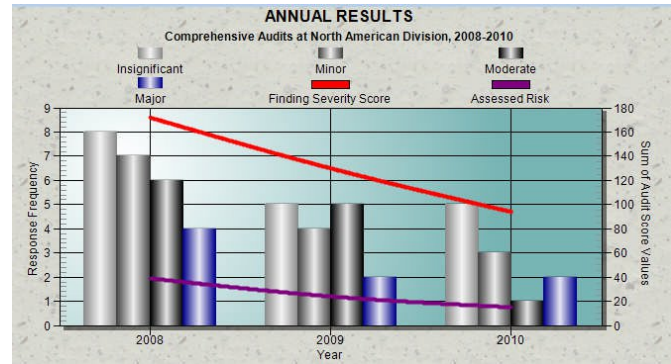
